General Requirements:

- 1. Tenderer/Bidder are required to submit one sample of Lady Bicycle. 20" and 22" and Gents bicycle 22" & 24" along with requisite ISI Certificate.
- 2. Warranty: Bicycle shall be supplied with a warranty for a period of one year against the manufacturing defects.
- 3. Tenderer shall declare the model name of the Bicycle for which they are quoting rates. Tenderer shall also submit the brochures/pamphlets of the quoted models along with technical data.
- 4. Tenderer shall also declare the weight of assembled bicycle including all accessories.
- 5. Tenderer shall submit ISI Certificate of various components like Frame, Fork, Handle Bar, Hub, Chain, Free Wheels Cranks, Chain Wheels, Rim, Seat Pillar, Steel Tubes.
- 6. Tenderer shall also provide any other items/part that is essential for complete bicycle which is not mentioned above. Wherever the specifications of an item is not mentioned, it should be of standard quality/reputed make.
- 7. Each Bicycle shall be visibly and legibly marked with Manufacturer's name and model.
- 8. Monogram of the Punjab Building & Other Construction Workers Welfare Board should be fixed on the frame, so that the Monogram is clearly visible (as approved by the Board) as shown in the picture of bicycle.
- 9. In the above Technical Specifications where ever it is mentioned that a particular part "shall conform" to a particular IS: specifications, the same shall be accepted only if particular part is IS mark. A supplier cannot take the plea that in case the part is not IS mark then this department can check that the part conforms to the specifications of IS

thus, the supplier shall have to produce IS Certificate for each of the parts mentioned in the technical specifications".

- 10. During joint inspection 100% supply will be physically checked and compared with approved sample. Out of every 500 (five hundred) numbers of bicycles, one bicycle will be got tested for destructive tests. Bicycles will be tested by Research and Development Centre (Bicycle) Ludhiana and they will charge Rs. 10/- per bicycle as testing charges.
- 11. Only the original manufacturers having manufacturing units in Punjab who have monthly manufacturing capacity of more than 10000 can quote the rates against this tender and they will have to submit the proof of manufacturing capacity.
- 12. Delivery Period: 30 days from the issue of supply order. If the party/parties fail to supply the bicycles within this delivery period, a penalty of 2% per month or part thereof will be imposed.
- 13. Any clarification regarding specifications can be obtained from the office of Punjab Building & Other Construction Workers Welfare Board, 17 Bays Building, Sector 17-D, Chandigarh.

Important Note:

- 1. Only the original manufacturers having manufacturing units in Punjab who have monthly manufacturing/supplying capacity of more than 10000 can quote the rates against this tender and they will have to submit the proof of manufacturing capacity.
- 2. The following documents are to be submitted in separate covers/envelops super scribed as Technical Bid and Financial Bid. Both these envelops must be put in a single envelops on which the complete address of the party be mentioned.

- 1. **F.O.R.** :Destination any where in Punjab as per the requirement of the field officers of Labour Department
- PRICE/TAXES: Rates should be quoted on firm basis for contract period from the date of work order up to 31.3.2016 without prices escalation or force majeure clause. Rate of Sales Tax/VAT/Inter State Sales Tax or any other chargeable duty must be specifically mentioned failing which no sales tax or duty will be allowed at a subsequent stage.
- 3. **PRICE CERTIFICATE**:- The tenderer must certify that the price quoted by them are not higher than those quoted to DGS&D and other Govt. Department.
- 4. **VALIDITY**: 90 days from the date of opening.
- 5. **PAYMENT**: 90% payment shall be made only against delivery at the destination and inspection Note. Balance 10% payment will be made within 30 days after the execution of complete order and receipt of goods as per NIT specifications of the Rate Contract / Supply order at destination.
- 6. **COMMITTED SUPPLY CAPACITY**: Quantum of committed supply per month basis item wise & size wise against this tender must be indicated clearly in technical bid.
- 7. The tendering firms from Punjab are required to furnish an affidavit on non-judicial stamp paper of Rs. 25/- duly attested from Magistrate 1st class that they are not defaulter in repaying the Punjab Govt. Loans if any obtained or not black listed by Punjab State.
- 8. **DISCOUNT:** Discount, if any applicable should be mentioned in the quoted prices. Discounts mentioned separately will not be considered. This should be part of Financial Bid only.
- 9. EARNEST MONEY: Earnest money of Rs. 5000/- & processing fee of Rs. 3000/- must accompany with each tender in the form of DD in favour of Punjab Construction Workers Welfare Board, Chandigarh only. - 12. "The copies of documents attached with the tenders (even Photostat copies) should be attested".
- 13. The Board reserves the right to amend the terms and conditions.
